### I. EMERGENCY AND FIRST AID PROCEDURE

#### **INGESTION**

- Never give anything by mouth if victim is rapidly losing consciousness or is unconscious or convulsing.
- DO NOT INDUCE VOMITING.
- Have victim drink about 250ml (8fl. oz.) of water to dilute material in stomach.
- If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration.
- Seek medical assistance.

### SKIN

- Flush contaminated area with water for at least 20 minutes.
- *Remove contaminated clothing under running water.*
- Completely decontaminate clothing before re-use, or discard.
- If irritation occurs seek medical attention.

### INHALATION

- *Remove victim to fresh air.*

### **NOTES TO PHYSICIAN**

• Symptoms of ethanol intoxication vary with the alcohol level of the blood. Mild alcohol intoxication occurs at blood levels between 0.05-0.15% and approximately 25% of individuals will show signs of intoxication at these levels. Above 0.15% the person is definitely under the influence of ethanol and 50-95% of individuals at this level are clinically

intoxicated. Severe poisoning occurs when the blood ethanol level is 0.3-0.5%. Above 0.5% the individual will be comatose and death can occur.

- The unabsorbed ethanol should be removed by gastric lavage after intubating the patient to prevent aspiration.
- Avoid the use of depressant drugs or the excessive administration of fluids.

#### VI. WHMIS CLASSIFICATION AND SYNERGISTIC MATERIALS


